Notice is hereby given that the Board of Directors of Cinco Municipal Utility District No. 8 will hold a regular meeting, open to the public, on **TUESDAY, 25 APRIL 2017**, at **12:00 noon**, at the offices of Coats Rose, P.C., 9 Greenway Plaza, Suite 1100, Houston, Texas 77046, outside the boundaries of the District, to consider and act upon the following matters:

1. Comments and questions from residents of the District (five-minute time limit);
3. Approval of the minutes of the meeting of 28 March 2017;
4. Tax Assessor/Collector's Report, including:
  - (a) disbursement of funds from the District's tax account;
  - (b) approval of any action necessary regarding delinquent tax accounts, including termination of services;
5. Bookkeeper's Report, including:
  - (a) authorize payment of the bills of the District;
  - (b) review investments of the District's funds;
  - (c) review draft of Operating Budget for the District for the fiscal year ending 31 May 2018;
6. Old business, including:
  - (a) review security report from the Fort Bend County Constable's Office the;
  - (b) status of the District's website and authorize any necessary action, including authorization to collect customer contact information;
  - (c) status of maintenance of the District's detention ponds and authorize any necessary action;
  - (d) status of compliance with the Phase II MS4 General Permit and Storm Water Management Program;
  - (e) status of the District's letter agreement with the Cinco Ranch Property Association, Inc. to provide recreational equipment at a park within the District;

7. New business, including:
  - (a) discuss renewal of the District's insurance coverage (expires 7 July 2017) and authorize any necessary action;
  - (b) authorize Tax Assessor/Collector and Bookkeeper to escheat unclaimed funds to the Texas Comptroller of Public Accounts;
  
8. Water conservation matters, including:
  - (a) review activities of the North Fort Bend Water Authority (the "Authority");
  - (b) discussion regarding communication, measures, education, and budget and authorize any necessary action;
  - (c) status of the W.I.S.E. Guys Program and authorize any necessary action;
  - (d) discuss participation in 2017 Larry's Toolbox rebate program through the Authority and authorize any necessary action;
  
9. Engineer's Report, including authorization to complete the sidewalk on the south side from the Chevron Station;
  
10. Operator's Report, including:
  - (a) report on operations of the District's facilities;
  - (b) termination of services to delinquent accounts;
  - (c) correspondence from customers of the District, including requests for adjustments or rebates;
  - (d) discuss and authorize any repairs, maintenance or other work deemed necessary;
  - (e) status of the rehabilitation of the Canyon Gate Lift Station and authorize any necessary action;
  - (f) status of Accurate Meter & Backflow, LLC smart meter pilot program;
  - (g) status of Water Usage Report to the Authority (due 1 March 2017) and 2016 Water Use Survey to the Texas Water Development Board (due 1 March 2017);
  - (h) status of annual emergency preparedness training;

12. Convene in executive session pursuant to Texas Government Code, Chapter 551, to discuss matters only relating to pending or contemplated litigation, personnel matters, real estate transactions, or security, if necessary;
