Notice is hereby given that the Board of Directors of Cinco Municipal Utility District No. 8 will hold a regular meeting, open to the public, on **TUESDAY, 22 October 2019**, at **12:00 noon**, at the offices of Coats Rose, P.C., 9 Greenway Plaza, Suite 1000, Houston, Texas 77046, outside the boundaries of the District, to consider and act upon the following matters:

1. Comments and questions from residents of the District (five-minute time limit);
2. Approval of the minutes of the meeting 24 September 2019;
3. Tax Assessor/Collector's Report, including:
 - (a) disbursement of funds from the District's tax account;
 - (b) approval of any action necessary regarding delinquent tax accounts, including termination of services;
 - (c) consider amended agreement for Tax Assessor/Collector services between the District and B&A Municipal Tax Services, LLC;
4. Bookkeeper's Report, including:
 - (a) authorize payment of the bills of the District;
 - (b) review investments of the District's funds;
5. Old business, including:
 - (a) status of Hurricane Harvey Litigation by Vujasinovic & Beckcom PLLC;
 - (b) status of claim for reimbursement from the Federal Emergency Management Agency;
 - (c) review of security report from the Fort Bend County Precinct 3 Constable's Office; consider Interlocal Agreement for Additional Law Enforcement Services between Fort Bend County and Cinco Municipal Utility District No. 8;
 - (d) status of the District's website;
 - (e) status of maintenance of the District's detention ponds;
